**LETTER OF PROTEST AND NOTIFICATION OF MISCARRIAGE OF JUSTICE

CHIEFTAINCY AFFAIRS KWARA STATE**

We are the solicitors acting for MALLAM AKOLADE IBRAHIM ABIOYE OLOYE AARE OF IDOFIAN LAND of Dedebioro Compound, Idofian, Kwara State hereinafter called our client and on whose instructions we write your Excellency as follows:

That our client being a Kingmaker in Idofian Land one of the High Chief that have power to nominate and select any aspirants to the stool of Oludofian of Idofian Land.

Sir, after the demised of the late Oludofian of Idofian Land LATE ALHAI ZUBAIR AGBOOLA OYESORO sometimes in June 2021, the 7 High Chiefs (King Makers) commenced the selection to the stool of Oludofian of Idofian and 3 out of the many aspirants aspiring to the stool of Oludofian of Idofian were selected and the King Makers notify the Honourable Commissioner for Local Government and Chieftaincy Affair in written but to our Client dismayed the Honourable Commissioner on 21st June, 2022 invited and held meeting with the 2 out of 7 King Makers that works on the selection and nomination of the candidates, the

In the light of the above facts, we pray that your Excellency hold that invitation of 2 King Makers out of 7 are nothing but a bid to misled your Excellency against the general wishes of Idofian Community and to regard same as Miscarriage of Justice against the people of Idofian Land and to avoid unrest in that community, we pray for your quick intervention for peaceful co-existence of that community.
