BEING A COMMUNIQUE ISSUED AT THE END OF IFELODUN LOCAL GOVERNMENT ALL PROGRESSIVES CONGRESS (APC) CRITTICAL STAKEHOLDERS' MEETING CONVENED BY HIS EXCELLENCY MR. KAYODE ALABI, THE DEPUTY GOVERNOR OF KWARA STATE ON MONDAY 17TH JULY, 2023 AT THE DEPUTY GOVERNOR OFFICE, ILORIN, KWARA STATE.

1. INTRODUCTION

The Deputy Governor of Kwara State, His Excellency Mr. Kayode Alabi called for a meeting of APC critical stakeholders in Ifelodun Local Government Area today, the 17th of July, 2023. The meeting was aimed to promote love, peace, and unity among the party members, and good people of Ifelodun Local Government at large. Identifying grievances among the party members as an aftermath result of the last APC primary elections, and anti-party allegation against some APC members during the last general elections, among other internal crisis are causes of loss of peace, love and unity in the party.

2. IDENTIFICATION OF PROBLEMS

- (b) Resistant of followers to the constituted authority,

- (d) Anti-party act in the last elections.

3. ADDRESSING THE PROBLEMS

In order to address the identified problems as above mentioned, the party members resolved thus:

- (A) To forgo the grievances emanated from the last election deliverance by some party members alleged of election anti-party,
- (B) Agreed to accommodate peace, unity and love in order to forge ahead,
- (C) The party structures are to be maintained in Ifelodun LGA,
- (D) New members are to be accommodated to foster peace and inclusiveness in the governance,
- (E) Party members agreed to place the Local Government Interest above the interest of any individual,
- (F) Leadership are saddled with the responsibility of fairness, justice, and equity to all party members.

(G) No party member to resist the directive of the constituted authority,

The party members agreed that Ifelodun Local Government Area is at a critical political time, therefore, the need for unity and progress of the local government is not negotiable with anyone. Addressing the above challenges will enable Ifelodun LGA gets what it deserves from the State and National Governments.
